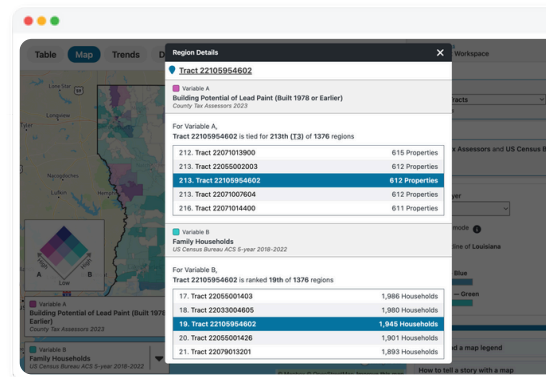

Our Community Health Assessment (CHA) and Improvement Plan (CHIP) templates were developed alongside respected local, county, and state public health departments to help you accomplish so much more than established industry and MAPP 2.0 requirements.

CHA	CHIP
breaks data down by race & ethnicity, sex, and age wherever available for each indicator.	enables you to track changes in objectives and progress in strategies and activities over time
visualizes indicators at the census tract level so you can identify patterns of inequities across space and relate them to historically disadvantaged groups	follows a Priority Area > Goals > Objectives > Strategies > Activities structure
has a templated listed of indicators that you can evaluate for how well it matches the responses in the "How Data Answer the Guiding Questions Worksheet."	is updated on an annual basis by the mySidewalk team
communicates complex topics such as health equity at an 8th-grade reading level.	can provide visualizations that will be helpful for PHAB accreditation requirements
organizes data using a SDOH + Context	is designed to represent the most important pieces for the public to understand – corresponding to Phase III's Step 7.5 item 3.
has been evaluated against the PHAB 2022 initial accreditation requirements.	can be modified to fit any alternative preferred organization style or additional items, media, methodologies, and more
